### **JOINT CAUTIONARY ANNOUNCEMENT**

Further to the cautionary announcements dated 5<sup>th</sup> September, 12<sup>th</sup> November and 11<sup>th</sup> December 2024 regarding the restructuring of Promotion and Development Ltd (“PaD”) and Caudan Development Limited (“CDL”) through a Scheme of Arrangement (the “Scheme”), the Boards of Directors of PaD and of CDL (the “Boards”) wish to inform their shareholders and the public in general that the Supreme Court of Mauritius (Bankruptcy Division) (the “Court”) has, on 22<sup>nd</sup> January 2025, sanctioned the Scheme pursuant to sections 261 and 264 of the Companies Act 2001 (the “Court Order”) as set out in the Listing Particulars/Information Memorandum dated 11<sup>th</sup> November 2024.

The Court has sanctioned the Scheme to be effective on 31<sup>st</sup> January 2025 and the Court Order has been filed with the Registrar of Companies on 23<sup>rd</sup> January 2025.
